Jawapan: / Answer:	BSN Micro/i Madani Sinar ialah satu kemudahan pembiayaan / pinjaman mikro yang ditawarkan kepada usahawan yang merupakan bekas banduan, bekas pelatih Agensi Anti Dadah Kebangsaan (AADK), Jabatan Kebajikan Masyarakat (JKM), Orang Kelainan Upaya (OKU) dan pelatih PERKESO bagi membantu mereka yang berhasrat mengembangkan perniagaan. / BSN Micro/i Madani Sinar is a micro financing / loan facility offered to entrepreneurs who are former prisoners, former trainees of Agensi Anti Dadah Kebangsaan (AADK), Jabatan Kebajikan Masyarakat (JKM), Special Need People status (OKU) and PERKESO trainees to assist those intending to expand their businesses.

Jawapan: / Answer:	<p>Langkah 1 : Layari laman web BSN untuk menyemak butiran produk. / <i>Step 1 : Visit BSN website to view the product details.</i></p> <p>Langkah 2 : Semak dan sediakan dokumen sokongan yang diperlukan. / <i>Step 2 : Check and prepare the required supporting documents.</i></p> <p>Langkah 3 : Kemukakan permohonan ke Pusat Mikro Kewangan BSN / Cawangan Utama Negeri BSN atau lakukan permohonan secara dalam talian. Pihak BSN akan menghubungi pelanggan dalam tempoh 6 hari bekerja selepas menerima dokumen yang lengkap untuk memaklumkan berkenaan status permohonan. / <i>Step 3 : Submit the application to BSN Micro Finance Centre / BSN State Main Branches or perform the application via online. BSN will contact the customer within 6 working days after receiving complete documents to update on the status of the application.</i></p>
