

Frequently Asked Questions (FAQ)

BSN SSP Limited Edition Umbrella Campaign

1. What is the Campaign about?

The "BSN SSP Limited Edition Umbrella Campaign" is a Campaign under BSN SSP that is open to all new and existing BSN SSP customers. Eligible customers will get a chance to win the BSN SSP Limited Edition Umbrella.

2. When is the Campaign period?

The Campaign will start from 1 January 2022 to 31 March 2022.

3. Who is eligible to participate in the Campaign?

All new and existing BSN SSP customers are eligible to join the campaign.

4. How do customers participate in the Campaign?

Eligible customers need to deposit a minimum amount of RM50,000 in once placement into their BSN SSP/SE account during the campaign period.

5. How can I make the deposit to participate in the Campaign?

There are two ways for new and existing BSN SSP/SE customers to make the deposit, the method as follows:

New to bank	Deposit can be made at the nearest BSN
BSN SSP/SE	Branch nationwide
customers	Branch nationwide
Exisitng BSN	Deposit can be made at the nearest BSN
SSP/SE	Branch nationwide or via myBSN online
customers	banking

6. What is the premium item offered to customers in the Campaign?

The BSN SSP Limited Edition Umbrella is offered to the first 500 customers from each state who makes a deposit of RM50,000 in a single placement.

7. How do customers claim for the BSN SSP Limited Edition Umbrella?

a) New and existing BSN SSP/SE customers who has made the deposit at the nearest BSN Branch nationwide.

If the deposit is made at any of BSN branch nationwide, the BSN SSP Limited Edition Umbrella can be claimed immediately after the transaction is deemed successful.

b) Customers who has made the transacton via myBSN online banking.

If the deposit is made via myBSN online banking, the BSN SSP Limited Edition Umbrella can be redeemed at the customer's state main branch.

c) The BSN SSP Limited Edition Umbrella is a premium item released by BSN specifically for this campaign. Eligible customers can redeem the umbrella while stocks lasts as the umbrella is given on a first come first served basis.

- d) For customers that have made the transaction at any BSN branch nationwide in January, the BSN SSP limited edition umbrella can only be redeemed on February onwards.
- e) BSN will then reach out to the customer to claim the umbrella at their nearest BSN branch.
- f) For customers who makes the transaction in February, immediate redemption can be done at BSN branch.

8. Can the premium item given be exchanged to cash or another product?

No. All premium items given are as is. The premium item can't be exchanged for cash or another product.

9. Is there a limit to how many times can a customer win the premium item?

Each customer can only win once throughout the whole campaign period and is on a first come first serve basis (while stocks last).
